

**CUSTOM ILLUSTRATIONS PROGRAM  
Addendum to the Author Services Agreement**

**I. CUSTOM ILLUSTRATIONS PROGRAM AGREEMENT**

This Custom Illustrations Program Agreement (“Agreement”) is made and entered into by and between the Author identified in the “Author Signature” section of this Agreement (“Author” or “you”) and Author Solutions, Inc., d/b/a AuthorHouse (“AuthorHouse” or “we”). The parties acknowledge that Author has entered into a certain Author Services Agreement with AuthorHouse (the “Author Agreement”) pertaining to the Work whose title is referenced on the signature page of this Agreement and pursuant to which AuthorHouse has agreed to distribute the Work and perform other services as instructed and paid for by you. You desire and agree to participate in the Custom Illustrations Program (the “Illustrations Program”) pursuant to which custom illustrations for the Work will be prepared (the “Illustrations”). Capitalized terms not defined in this Agreement will have the meaning ascribed to such terms in the Author Agreement unless the context dictates otherwise.

**II. DESCRIPTION OF PROGRAM SERVICES**

1. AuthorHouse will provide Author with the services of the Program performed by an Artist (“Artist”) who is skilled and proficient in a variety of artistic styles and mediums. Artwork will be produced in any of the following media: graphite, ink, charcoal, pastel, digital, watercolor, collage, photography, fabric, or any combination of these media or other available media at the Author’s request and the Artist’s ability.
2. Creation of a single illustration as a double-page spread (spanning from one page across the fold to the facing page) constitutes two (2) illustrations, and must be purchased as such.
3. Illustrations will be made available in high resolution (300 d.p.i.) TIF or JPG format to be included in Author’s book interior.
4. Author agrees to submit a completed Custom Illustrations Submission Information Form to AuthorHouse before AuthorHouse commences any illustrations. Author must select an Illustration Level as requested on the on the Custom Illustrations Submission Information Form.
5. Service is limited depending on the complexity of the illustration submitted on the Custom Illustrations Submission Form. AuthorHouse agrees to contact Author before commencing any illustration if the submitted illustration will require a higher Illustration Level than the level selected on the Custom Illustrations Submission Information Form.
6. AuthorHouse retains the sole right to quote an appropriate Illustration Level based on information in the Custom Illustration Submission Information Form. In the event that AuthorHouse requests a change of Illustration Level, Author retains the right to refuse this request. If Author refuses this request, Author is entitled to a full refund of any fees paid ONLY for Illustration services.
7. AuthorHouse will make all reasonable efforts to produce initial sketches within thirty (30) business days of initial Custom Illustrations contract and final artwork for author approval within thirty (30) business days of the initial Illustration Consultation call. However, more time may be needed, as deemed necessary by the Artist and/or the Author and will be determined on a case by case basis. The production of the Illustrations is separate from the

production of the galley and cover and this Agreement does not obligate AuthorHouse with regards to the production timeline of the interior galley or cover formatting.

### **III. ELIGIBILITY AND REQUIREMENTS**

1. All soft cover and hard cover books published by AuthorHouse are eligible to participate in the Illustrations Program.
2. Author must notify AuthorHouse within fourteen (14) days of AuthorHouse sending the artwork if Author is dissatisfied with the artwork. If AuthorHouse agrees that the quality of the cover artwork does not match the original concept design agreement, AuthorHouse will provide a modified design at no charge to Author. In no event will AuthorHouse's liability for unsatisfactory services exceed the amount paid by Author for the services. Author's only remedy in a dispute against AuthorHouse under Agreement is a refund of money already paid to AuthorHouse for Illustration services.

### **IV. REMEDIES AND LIMITATIONS**

1. Author acknowledges that an Illustration does not constitute, nor should be construed as, a guarantee of book sales. Author acknowledges that AuthorHouse has no control over the purchasing decisions of customers and will not be liable to Author if the Work does not sell.
2. AuthorHouse retains full rights to Illustration(s) produced as a part of this Agreement and reserves the right to use it in whole or in part for promotional campaigns. AuthorHouse grants the Author a Limited License to use the Illustration(s) for promotional and advertising purposes. Author shall be provided with a high resolution TIF or JPG of the approved Illustration. After Author's final approval, AuthorHouse can not alter the Illustration to satisfy additional uses deemed by the Author.
3. Author will be bound by this Agreement upon sending an executed original of this Agreement to AuthorHouse at its address noted in the Author Agreement. Alternatively, facsimile or electronic transmission to AuthorHouse by Author of the executed version of this Agreement will have the same force and effect as the original and will constitute Author's agreement to be bound by this Agreement. As to AuthorHouse, this Agreement will be deemed to be accepted by, and binding upon, AuthorHouse at such time as AuthorHouse receives confirmation that full payment from Author for the services associated with the Illustrations Program has been received and irrevocably credited to AuthorHouse.
4. You expressly acknowledge and agree that this Agreement is entered into pursuant to the Author Agreement, the terms and conditions of which are hereby incorporated by reference herein. Author's participation in the Illustrations Program and the performance by AuthorHouse of its obligations under this Agreement will be deemed to constitute "Services" as defined in the Author Agreement and all of the provisions of the Author Agreement will apply equally to this Agreement, including, specifically, without limitation, the provisions of Sections 2 (pertaining to representations of Author), 4 (pertaining to limitations of liability and indemnification), 6 (pertaining to limitation of remedies), 7 (pertaining to breach of default and termination), 9 (pertaining to waiver), 10 (pertaining to force majeure), and 13 (pertaining to governing law, arbitration and jurisdiction). Further, the provisions of the Author Agreement, to the extent they generally limit AuthorHouse's liability and otherwise protect AuthorHouse from liability to Author, will apply to any claims by Author against AuthorHouse. In the event of any conflict between the terms of this Agreement and the Author Agreement, the terms of the Author Agreement will be controlling and take precedence.
5. If any part of this Agreement is found to be invalid or unenforceable, the remaining provisions of this Agreement shall continue to be binding and effective.
6. By signing you acknowledge that you have read, understand and approve the terms of the foregoing Agreement and agree to be bound by its provisions. Please sign and return this Agreement via facsimile to 1-812-961-1023.

**Custom Illustrations Agreement Sign-Off Section**

***Description of Levels***

*Level 1:* This illustration level provides you with basic line art. The lines can be heavy or light and the colors can be muted or bright to fit your needs.

*Level 2:* This illustration level has a moderate level of shading and detail. The lines may be varied in width and the shading provides more depth to the illustration.

*Level 3:* This illustration level offers the most realistic portrayal of the subject. Detailed shading, texture, and varying color values create a composition of accurate rendering.
